Direct Debit is the easy and convenient way to pay for your Friends of Holy Cross membership. With Direct Debit your subscription comes out of your bank automatically and there's no need to send cheques every year. Please complete the Direct Debit instruction below. This will be used to instruct your bank or building society to pay the Direct Debit.

The Direct Debit Guarantee

This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.

- If there are any changes to the amount, date or frequency of your Direct Debit Friends of Holy Cross will notify you at least 14 working days in advance of your account being debited or as otherwise agreed. If you request Friends of Holy Cross to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit by Friends of Holy Cross or your bank or building society you are entitled to a full and immediate refund of the amount paid from your bank or building society. If you receive a refund you are not entitled to, you must pay it back when Friends of Holy Cross asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.
